*Brandi Peterson is from Harlem, New York and currently serves as a community organizer for The National Council for Incarcerated and Formerly Incarcerated Women and Girls, as well as Step Beyond Women and Girls. As a formerly incarcerated woman, Brandi is deeply passionate about inspiring and empowering youth to build a brighter future. She is a firm believer that ending the incarceration of women and girls and uplifting our young people is key to creating lasting change.*



## *Danielle Metz, Louisiana*

*Danielle Metz is a nationally recognized criminal justice reform advocate and abolitionist, committed to uplifting the voices of incarcerated and formerly incarcerated individuals. Her lived experience within the system of mass incarceration fuels her relentless pursuit of justice, equity, and second chances.*

*Currently, Danielle serves as the Chief Executive Officer of Pep Rallies to Professionals, an organization she founded to promote education, empowerment, and public awareness. Danielle also serves as the Clemency Coordinator for the National Council for Incarcerated and Formerly Incarcerated Women and Girls, a board member of the Louisiana Community Health Outreach Network (LACHON), and a national community health worker with the Common Indicator Project.*

*She remains deeply committed to breaking generational cycles of incarceration by investing in the next generation and paying her journey forward.*



## *Darlisa Ware, Arkansas*

*Darlisa Ware, is a resilient leader who has transformed pain into power and purpose. With an associate degree in Religious Studies and a bachelor's degree in Psychology, she is currently pursuing her master's with unwavering determination. As the founder of World Changers of America Advocacy Group, she passionately advocates for the underprivileged and underserved in her community. She also established a non-collegiate Greek social club for women, rooted in sisterhood, service, and meaningful travel experiences. Darlisa's journey is a powerful testimony of triumph having experienced sexual abuse, police brutality, domestic violence, and heartbreak, she continues to rise. Her life reflects a deep commitment to healing, empowerment, and helping others do the same. Through faith, education, and action, she proves that even in the face of adversity, dreams are still worth chasing.*



## *Emilee Shell, Mississippi*

*Emilee Shell found her voice by advocating for women who've been criminalized due to human trafficking. She is the Director of a sober living program for justice-impacted women recovering from substance use disorder, and the founder of Exchanging Pathways, where she focuses on legislative advocacy, reentry consulting, and voting rights restoration. Additionally, she is the Programs Director with the Mississippi Impact Coalition. She has organized nationally with the Poor People's Campaign and helped lead Mississippi's Clean Slate coalition. She is currently a Business major with a Sociology minor at Jackson State University. Her work is rooted in the belief that public health is public safety, with a focus on harm reduction, Clean Slate policy, and expanding Medicaid access after incarceration. She is deeply committed to building power with and for directly impacted communities, especially in the South.*



## *Jan Rogers, Florida*

*Jan Rogers, a Care Coach on the Kentucky Humana Beginnings team works to support the needs of pregnant and postpartum individuals across Kentucky. A Reproductive Justice activist born and raised in the West End of Louisville, KY, Jan was inspired to begin Reproductive Justice work at an early age after learning the story of her paternal grandmother's passing during child birth. Jan graduated from the University of Louisville with a BS in Public Health and Information Sciences with a focus in Maternal Child Health. Soon after graduating, Jan became a birth and postpartum doula and began serving the community as a birth support worker ensuring that birthing individuals have the tools needed to build a strong foundation for their families. Jan has served in roles within the Louisville Metro Public Health and Wellness Center for Health Equity where she was able to create programming that supports pregnant and postpartum individuals and their families through education, providing resources, advocacy and mental health initiatives. The Neighborhood Nest, a local maternity pantry was one of the*

programs erected through a partnership with local libraries. Jan was provided the opportunity to lead Healthy Babies Louisville, a coalition of healthcare providers, social service agencies, academia, birthing hospitals, non-profit organizations and grassroots lead organizations dedicated to improving maternal child health outcomes within Louisville and Kentucky. Through exploration of the intersectionality of social justice issues, Jan has began work in housing justice and food apartheid.

After serving a five year prison sentence, she earned her degree in Innovation and Leadership and made it her mission to help others do the same. In 2021, she led the successful effort to remove the criminal history box from all college applications in Oregon. Now she focuses on expanding prison education and creating real pathways to opportunity.*



## *LaChandra Moore, Arkansas*

*LaChandra Moore is the founder and CEO of OneMoreKiss, a nonprofit dedicated to raising awareness about the dangers of fentanyl, promoting harm reduction, and supporting individuals and families impacted by addiction. Her advocacy has earned her two community activist awards, one from Dream.org and another from New Life in Christ Church. She is also a devoted mother of four and a grandmother of nine, passionate about creating positive change in her community.*



## LaCrecia Day, Alabama

LaCrecia Day is the Programs Director at Offender Alumni Association, where she leads initiatives to empower case managers serving diverse populations. With over 20 years of experience in program development, management, and finance, she previously served at IMPACT Family Counseling, where she created and directed the PROVE Program, led the UTurn Program, secured millions in grant funding, and held roles in case management, instruction, and financial oversight. LaCrecia holds a Bachelor's degree in Business Administration and a Master's in Finance. Deeply committed to service, she volunteered for over 18 years as Alabama Statewide Coordinator for Angel Tree through Prison Fellowship Ministries, as well as with various other community organizations.

## LaToya Spillman, West Virginia

After being incarcerated LaToya Spillman found her voice advocating for women with lengthy sentences for drug trafficking and conspiracy charges for people arrested for the first time. She works as a Recovery Coach at Health Path Integrity which is a non-profit organization that serves impacted men and women suffering from mental illness

*and substance use. She also works with reentry programs to help women and men get housing and identification before leaving prison. She is also part of the West Virginia Criminal Law Reform Coalition. They work with delegates at the State capitol to get bills passed into law. She collaborated with the delegates in 2016 on the House Bill 2459 which is the Snap benefits for people convicted of drug offenses which passed in 2019. All people in the state of West Virginia who are convicted of felony offenses are eligible to get Snap benefits and housing. Latoya is currently working on the Clean Slate Bill that allows certain convictions to be sealed or expunged and gives people second chances. She is dedicated to helping people who are justice impacted and deeply passionate about working with the state of West Virginia on prison reform.*



## *ML Smith, Missouri*

*ML Smith is a criminal punishment system-impacted advocate, abolitionist and activist who experienced incarceration during the COVID-19 pandemic, which made her intimately aware of the dire reality faced by our imprisoned populations, as well as the egregious actions and apathy of institution staff and administrators.*

*Being a Black, disabled, system-impacted woman who has experienced generational poverty is the foundation of her ideological framework, rooted in advocating for those suffering & struggling within a society created and built to oppress, marginalize and dehumanize targeted, vulnerable communities. ML is dedicated to using her experiences, knowledge, determination and voice in the struggle for equity, justice and recognition of humanity.*

*ML's advocacy efforts extend to all facets of mass incarceration, including wrongful convictions, higher education for system-impacted people, humane and adequate healthcare, legislative reforms and decarceration. ML serves as the Executive Director of Missouri Justice Coalition, as well as serves as a leader/advisor within several local and national organizations' coalitions & cohorts.*



## Nicole Davis, Illinois

*Born and Raised on the Westside of Chicago, Nicole Davis is an author, public speaker, mentor, organizer, activist, and advocate deeply committed to ending mass incarceration. She is the founder and CEO of the Talk2mefoundation, a nonprofit dedicated to breaking the cycle of generational incarceration. Nicole holds an associate degree in Business Management and uses her education and lived experience to empower justice-impacted individuals and their families. Through initiatives like the Sisters of Support House, she provides safe housing, mentorship, and workforce development for formerly incarcerated women. Her work is rooted in healing, second chances, and transforming communities through justice reform.*

## Shakiethia Wheeler, Georgia

*Shakiethia is the founding President and Executive Director of Southern Women In Motion Foundation Inc., a nonprofit organization that provides safe, supportive housing & re-entry services to justice impacted, disadvantaged women. She is a proud black mother of four, a 20-year entrepreneur and a native of Atlanta Georgia with a lived experience in the criminal justice system. She is dedicated to this work and eagerly ambitious as she leads S.W.I.M Foundation into the criminal justice reform movement. Her mission is to provide suitable*

*housing and wrap around services to unsheltered women who are directly impacted by the justice system. She is a leader within her community and collaborates with community partners, nonprofit organizations and other leaders to organize and advocate for justice, diversity and to bring awareness to the issues of mass incarceration and inequality within the Black and Brown communities.*

*Shaneka Jones is the Reentry Program Coordinator for the City of Little Rock, where she is dedicated to providing 2nd chance opportunities for justice-impacted individuals. Having personally experienced the justice system, she understands the critical need for*

*support and resources upon reentry. Shaneka leads efforts to connect individuals with employment, drivers license reinstatement, expungement and record sealing, voter rights restoration, and more. Her lived experience fuels her passion for creating meaningful change in the reentry process. She believes that resources are not optional-they are essential to success after incarceration. Through her work, Shaneka advocates for second chances not second sentences.*

She works with students with behavior issues due to displacement in foster care, being arrested, and other traumas. *Terri Minor-Spencer is the Founder and Executive Director of the grassroots non-profit organization West End P.O.W.E.R. – whose mission is providing opportunities with effective resources by giving back by doing works of service with employment support(s), educational civics & awareness, etiquette empowerment, and social/home needs.*

*She is also the Outreach Coordinator of The Community of Change Center – a safe community space for community members, unity building, returning citizens and guests to have fun, job readiness, adult g.e.d. 6-month schooling, home economics, Spanish class, and Entrepreneur Readiness. *Terri is a member of the Center for Shared Prosperity Committee, whose mission is to dismantle economic, cultural, social, & structural barriers of entry. *Tiffani Shaw is a passionate advocate, motivational speaker, and community leader who has transformed her lived experience with incarceration and addiction into a powerful force for change. In just two years since her release—and now over six years sober—she*

*has rebuilt her life while helping others do the same through her work at JusticeLink, her certification as a Peer Recovery Support Specialist, and mentoring women through a support group called Footsteps. She also volunteers with reentry programs, serves on the Community Advisory Board for the Making A Way Foundation, and advocates for policy change with Oklahomans for Criminal Justice Reform. In 2024, she spoke on a U.S. Senate panel in support of SB3190 to protect SNAP benefits for those in reentry programs and continues to raise her voice nationally through platforms like the Clean Slate Initiative. Tiffani is living proof that second chances work, and she is committed to transforming pain into purpose while bringing love, justice, and restoration back to her community.*



## Dr. UniQue C. Starks, New York

*Dr. UniQue C. Starks is a visionary leader in social work, holding a Doctorate in Social Work from the University of Southern California and a Master of Social Work from New York University. With over a decade of experience in mental health, restorative justice, advocacy, and community*

*Janet Hughes is a Los Angeles native. She is a leader in the Sisterhood Strategy Team for Essie Justice Group, a sister/member led organization. Joining Essie Justice Group has allowed her to use her leadership and advocacy skills for everyone who has been impacted by mass incarceration. In being an advocate, it has led her to be a part of Essie's Campaign Team, working on the local campaign to close the Men's Central Jail and the state bill for incarcerated pregnant people in tandem with the Solis Policy Institute. As a life coach, with her own organizations, Finances Simple and Healing N Wholeness, she uses her voice to help people put into practice caring for their financial traumas and having mindfulness of their soul care. She's trained and certified in several therapeutic modalities to guide healing. Janet knows if our community works together we can have the best we deserve.*



## Jessica Drew Umberger, Georgia

*After serving a five-year sentence, Drew Umberger became a Certified Peer Recovery Empowerment Specialist who has dedicated her life to helping others, particularly incarcerated women and underserved communities in Atlanta. Originally hailing from Winston-Salem, North Carolina, Drew is currently working towards her B.A. from Atlanta Tech. Drew joined the Policing Alternatives & Diversion Initiative in August of 2022 as a Peer Advocate on the Street Wellness Enhancement & Engagement Team, providing intensive-street level peer support to unhoused individuals experiencing serious mental health concerns. Now as a Care Navigator, Drew provides case management to people impacted by the criminal legal system through a harm-reduction, person-centered approach. Drew is actively involved in several organizations based in Atlanta, including Motherhood Beyond Bars, Living on Purpose ATL, Women in Transition, Support + Feed, and ATL Free Fridge. When not working or studying she enjoys spending time with her children and doing home improvement jobs to her home she just purchased in December.*



## Justine Moore, New York

*Justine Moore, a native of Brooklyn, NY, served 16 years of a 20-year sentence. Even prior to her release from prison Ms. Moore decided she needed to make a difference, she participated in the CHOICES program where incarcerated women shared their life experiences with students from the local high schools, group homes, college students, lawyers, judges and politicians. Ms. Moore also was part of a group of women in the prison who began to have discussions about the criminal justice system and how they could use their expertise to help create change. Upon release Ms. Moore began sharing her story and organizing formerly incarcerated women as a co-founding member of The National Council for Incarcerated and Formerly Incarcerated Women and Girls. She is also founder of Empowerment: Before, During and After. Currently she serves as the Director of Training for The National Council and part of the training team for Silicon Valley Debug.*



## Katrina Butler, Georgia

*Katrina Butler is a resilient woman, published children's book author, and social impact life coach who has transformed life's challenges into opportunities to inspire and assist others facing similar hardships. As the founder of "Different Souls on One Accord" and "So Far So Close," Karina's organizations are dedicated to supporting women survivors of domestic violence and incarceration toward freedom, self-worth, and empowerment utilizing a holistic approach of peer mentorship and restorative justice principles. Her commitment to her work has led her to obtain certifications in Social Justice Life Coaching and Restorative Justice Facilitation. Currently pursuing higher education at Georgia State University and Strayer University, Karina lives by the words, 'Never forget where you came from and stand on your truth no matter what!' She believes it is only when we stand in our truth that we can foster personal growth and work towards the betterment of humanity.*



## *Lisa Guss, Alabama*

*Lisa Guss is the Family Engagement Specialist at Offender Alumni Association (OAA), Credible Messenger, Pastor and Peer Specialist. She is the ultimate example of a success when given a second chance. She has previously served as Senior Case Manager in the PROVE program with*

*Lisa credits a portion of her road to success to her 99 year prison sentence that she was given but through God's Favor and Blessing, she received an early release after doing 25 years.*

*Lisa's desire is for others to follow her lead and live a productive life and bring life, hope, help and healing to the families and communities they once destroyed. Lisa is a Messenger not only of the Gospel but also to bring life to what was once considered a dead situation.*



## *Maria Morris, Oklahoma*

*Maria, a former award-winning culinary arts student and talented chef, tragically lost her 22-month-old daughter in a house fire in 2018. Despite being wrongfully arrested and imprisoned for her daughter's death, Maria continues to use her trauma and culinary gift*

*to help others triumph. In January 2020, she created Carabelle's Legacy to aid women who have experienced loss and justice system involvement. Maria currently advocates for the underprivileged, providing second-chance employment and training through her catering business, and increasing fire safety awareness in the community.*



## Marion Rodriguez, Texas

Marion is the Creative Founder of MUVSU What Moves You?. MUVSU's mission is to uplift and support formerly incarcerated women and to educate and empower the masses. Every one of a kind bag is significant because when women are incarcerated they are stripped of their possessions. The empty bag represents a new beginning and a fresh start. Personalized note cards of encouragement are included in every bag. The therapeutic value of creating and giving is Marion's privilege, especially since she is formerly incarcerated. Women who are gifted a bag are grateful to know that people care and support her in the journey to re-enter society. Since 2020 Marion has created, sold, and gifted over 3000 bags. MUVSU bags are sold in 7 women-owned businesses in Texas and New York.



## Marsha King, Virginia

Marsha King's life journey has been shaped by her personal experiences with the justice system, which taught her the critical importance of having an advocate on the outside. Her passion for the protection of inmates' rights has inspired her to become an activist, serving as a voice for incarcerated individuals and their loved ones. Marsha is committed to providing a range of prison services that enable prisoners and their families to navigate the complex legal and administrative processes involved in incarceration. Marsha also serves as a resource for those who have been impacted by the policies of the penal system and is dedicated to fighting for human rights in this context. She is deeply committed to ensuring that these rights are honored even after a sentence has been completed, and she believes that this is critical for the well-being of both individuals and society at large. In addition to her work as an advocate, Marsha is also committed to promoting legislative policy that addresses the accountability of lawyers and judges who violate the rights of offenders during the pretrial phase. She believes that this is essential for ensuring that previously incarcerated individuals are able to achieve meaningful and lasting restoration.



## Melinda Johnson, California

*Melinda Johnson is a Black Certified Birthing Doula, Emotional Wellness Coach, Domestic Violence Coach, Mental Health First Aid Responder, Motivational Speaker, Author and Poet.*

*She is the founder of the Self Determination Initiative, a nonprofit organization designed to prepare incarcerated, formerly incarcerated, and their family members to prepare for their release from prison, identify reentry barriers, and how to navigate the reintegration process. Her passion comes from being formerly incarcerated and learning how to rebuild her and her children's lives after being incarcerated. She has twenty-five years' experience working with this community.*

*She is also the founder of Hidden N' Him, a nonprofit organization that holds sacred space to educate and empower women through intimate conversations that navigates through releasing pain, healing, restoration, and child birthing.*

## *Noreen McClendon, California*

*Noreen McClendon is the Executive Director of Concerned Citizens of South Central Los Angeles (CCSCLA) and is responsible for day-to-day management of the non-profit founded in 1985. CCSCLA developed over 700 units of affordable housing, an 80,0000 s.f. grocery-store anchored shopping center, provided job training and placement assistance, entertainment industry training and re-entry services for community residents and been a co-sponsor of the Central Avenue Jazz Festival since its inception in 1995.*

*CCSCLA was involved in gang intervention from 2005-2013. Ms. McClendon teaches anger management and curriculum she developed based on her book HURT PEOPLE HIGHWAY, Identifying Unhealthy Elements in Relationships, (published in 2018) in various prisons in California.*

*Ms. McClendon received her education in the Philadelphia public school system, studied Electrical Engineering at Clark College, received a Certificate in Engineering and Construction Management from UCLA and completed the USC Minority Program in Real Estate.*



## *Rose Harris, New York*

*Rose Harris is the Director of Adult- Young Adult Initiatives at the Women's Community Justice Association. Along with a 4 page criminal record and not being able to hold down a job, I thought that I was destined to fail. Today by the grace of God, I was able to not only learn to live a sober life, I continued to pray and worked diligently to be reunited with my children, which has been one of my biggest accomplishments. I then graduated from Philander Smith College with a Bachelor's in Social Work in 2017 from a HBCU college in which I always wanted to attend growing up. I went on to obtain my Master's in Social Work in 2021, and am currently pursuing a Doctoral in Social Work.*

She was determined to do something positive with the rest of her life and since founded Redeeming Kimberly in 2019. -- a nonprofit dedicated to assisting returning citizens*

Woodson now serves as campaign organizer for Michigan Liberation and is the mother to 4 yr old, Jai'Marie, her miracle baby born in 2017.



## Latanya Pierce, New Jersey

Tanya R. Pierce, MBA, is the Founder of Life Unbolted, which supports people impacted by the federal carceral system. She created the Young Adult Initiative (YAI), a peer-led training, mentoring, coaching, and accountability cohort-style training for federally impacted individuals

aged 18-24. YAI empowers the participants by providing a pathway and blueprint of life-changing programming, community healing, and health. The program collaborates with the U.S. District Court - Eastern District of New York Special Options Services (SOS) Alternative to Incarceration (ATI) Program. Before that, she was a co-designer of the Columbia Law School Paralegal Pathways Initiative (PPI), which aims to amplify the talents of formerly incarcerated individuals by providing skills-based legal training and connecting them with professional mentorship in preparation for a legal career. Tanya is a federal criminal justice reformist working to dismantle systemic barriers perpetuating pre-entry and re-entry disparities in programming and policies for all individuals impacted by the federal injustice system.



## Lauren Johnson, Texas

Lauren Johnson is a policy & advocacy strategist at the ACLU of Texas, where she focuses on criminal legal reform as part of the Smart Justice team. Her experience as someone who is formerly incarcerated informs her advocacy on issues ranging from Fair Chance Hiring to

reducing sentencing guidelines for low-level drug crimes and improving prison conditions, especially for women. Before joining

the ACLU staff in 2017, Lauren worked as an activist and volunteer to pass the first Fair Chance Hiring ordinance in the Southern U.S. that applies to private employers. 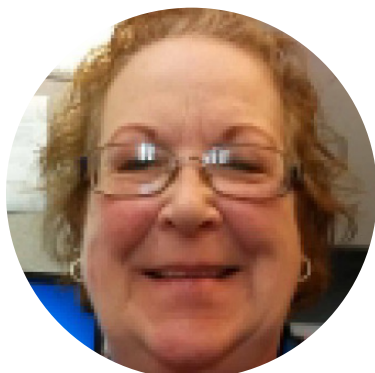


## Naquasia Pollard, New York

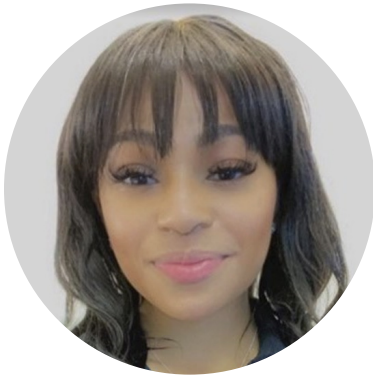
## Shameeka France, New York

She is well versed in her community and well respected in the field of Human Services. She is also a current student in Columbia Law School participating in the Theater of Change: Reimagining Justice through Abolition social change work, the arts provide a vital space to imagine alternative solutions to our broken systems and promote those alternate futures as achievable realities. In this course, Ms. France has developed her individual and collective ability to blend artistry, law, policy, and community engagement to produce pieces of impactful activism in policy spaces where change can happen.*



## Sharon Turner, Georgia

*Sharon Turner is a grassroots activist and community organizer and social entrepreneur living in Atlanta Georgia fighting for equity, freedom and justice on behalf of marginalized populations on a local and national level. Her lifelong pursuit of learning through personal and educational experiences has developed herself into the leader she is today. She has received several accolades of accomplishments, however some of the most meaningful are the women led fellowships cohorts with Women Organizing for Justice and Opportunity (WOJO), Ladies Of Hope Ministries (LOHM) DOULA Initiative, and now Women Transcending and the Collective Leadership Institute.*

She dedicates a large portion of her advocacy to helping other mothers overcome the same challenges that she experienced with regaining custody post incarceration.*

*Tanya Smith's strength is from a long line of Strong Brown Women who've contended with systemic racism in some form or fashion. They've molded her to be the fierce mother of three beautiful daughters in whom she feels are her greatest accomplishments. She has been chosen to be a grandmother of three beautiful granddaughters. She served in the community of Human Services as a Mental Health/Substance Abuse, Domestic Violence and Child Welfare provider for over 18 yrs in the City of Waterbury CT and most recently in The Bronx, New York. *Pamela Winn is an activist from Atlanta, GA and single mother of two sons that studied Biology at Spelman College, obtained three post-secondary degrees in Nursing, and worked more than 10 years as a Registered Nurse specializing in Women's Health prior to serving a 78-month federal sentence for a white-collar crime while*

*pregnant. During her incarceration, she was shackled, causing her to fall and miscarry, then placed in solitary confinement. Rather than diminishing her spirit, Pamela allowed the separation of her family, a miscarriage, revocation of her nursing license, and closing of her businesses that she experienced while in prison to empower her. Pamela Winn is the founder of RestoreHER US.America, a policy advocacy reentry organization dedicated to enhancing the lives of directly impacted women and work in partnership with those women to end the mass incarceration of women of color and pregnant women. RestoreHER is a core movement partner of Southern Black Girls and Women.*



## Quniana Futrell, Virginia

Quniana Futrell is from the streets of Newark, NJ, having two incarcerated parents featured on PBS's Emmy award-winning show, *Virginia Currents*. Quniana Futrell, known as "Author Q.", is a real success story and champion for change. Quniana captivates audiences from all over the world, from the United States to Uganda, with her straightforward and realistic methods to resilience and healing. She builds champions from the inside out using her proven methods as a Certified Trauma Professional. Quniana has been recognized by both international and local media outlets for her work. She is a captivating keynote, author and award-winning filmmaker shaking up the norm and changing lives.



## Sharon "Shay" Smith, Florida

Sharon M. Smith (Shay) born and raised in the Bronx, now residing in Winter Haven, Florida. She Served 6 years total in prison, 5 years in a state prison and 1 year in federal prison. After being released from state prison 1998 she worked for the Center of Employment Opportunities as a site supervisor in the Supreme Court building in Brooklyn, New York for 10 years. This program helps formerly incarcerated women and men build skills in building and floor maintenance (stripping, buffing, waxing etc.) until placed on permanent Jobs. In 2009 she went to federal prison for 1 year for a money transgression (conspiracy charge) she sat in Danbury Ct. prison with women who talked about the criminal justice system. And how we need to dismantle this system. She was released in 2010 and began working for a moving company as the supervisor of contract hiring. She would hire over 100 formerly incarcerated women and men all over NYC for summer employment for 11 years. Over the years, Shay has stayed in contact with the women from Danbury, CT prison who created The National Council for Incarcerated and Formerly Incarcerated Women and Girls. She attends the #FreeHer conferences and has also volunteered over

the years. Today Shay is a National Organizer for The National Council for Incarcerated and Formerly Incarcerated Women and Girls. Here is where she has re- united and joined the fight to end incarceration of Women and Girls.



## *Sharon White-Harrigan, Connecticut*

Sharon White-Harrigan, is the Executive Director of the Women's Community Justice Association (WCJA), a gender-focused, trauma-informed, advocacy-for-justice agency. Prior to joining WCJA and leading the BEYONDrosies2020 campaign, Sharon was the Program Director at the Women's Prison Association. She became a resident of A New Way of Life and after being there a year, Bleu became the housing Coordinator where her new way of Life continues. She speaks on how unresolved traumas as youth affects the choices as women.



### *Ayoola Mitchell, California*

Born and raised in San Francisco, California, Ayoola Mitchell has spent more than three decades working in the punishment system, as a fierce advocate for those impacted. She currently works full-time developing, overseeing and facilitating programs in jails and prisons. She believes the most important aspect of her life is being a Mother and facilitating healing within her family and in communities. Ayoola's world changed drastically over a decade ago when her family experienced not one or two but three separate tragedies. In a little

more than four years, Ayoola experienced her oldest son surviving 17 gunshot wounds only to lose her middle son to murder 15 months later. Less than three years later, her Godson was killed by a drunk driver. Although initially self-identifying as a Survivor, Ayoola found her greatest strength, power and resiliency on her Healing Journey. She is a firm believer in the importance, necessity and power of healing. She often states, “We must stop looking for things externally to heal us internally”. In what she sarcastically refers to as her infinite free time, she loves spending time with her family, reading and writing.



## Cass Severe, New Jersey

Cass Severe is a mother, certified social worker, survivor, activist, credible messenger, and change agent living and working in Newark, New Jersey. She currently works with the Newark Housing Authority to support the Asset Manager and the Department of Operations. Cass previously worked as advertised Project Manager at Newark Community Street Team. NCST is a community-based violence reduction strategy that trains and deploys Outreach Workers and High-Risk Interventionists in the South and West Wards. With valuable life experience and through the traditional Indigenous teachings she has inherited, addressing harm, trauma and violence through ancestral knowledge has brought purpose and passion to her work. This is vital in order to bring forth the healing her people deserve, co-powering with the sharing of Indigenous ceremony and brilliance so that it may enter the hearts and minds of all people from all directions. Fully engaged in community she diligently strives to bring forth the truth of indigenous history, along with changes necessary to dismantle the many forms of oppression imposed on the original descendants of this continent.*



## *Kimberly Haven, Maryland*

*Kimberly Haven is a thought leader and a powerful voice and force in the social justice movement. She is a focus-issue expert and is a frequently called upon speaker on issues such as Women in Prison, Women's Reproductive Justice, Voting Rights and Democracy, Collateral*

Her goal is to use her educational and life experiences to convey a message of strength and hope in the community as well as a message of recovery, restoration and redemption.*



## *LaTonya A. Tate, Alabama*

*LaTonya A. Tate is a national leader, social justice activist and a retired Probation and Parole Officer formerly with the Florida Department of Corrections. She is often called upon speak on panels as an expert on probation and parole reform. *years in prison under Florida's harsh minimum mandatory sentencing policies. Her story gained national attention and shed light on harsh minimum mandatory sentencing policies as well as the Stand Your Ground Law. Marissa Alexander is a public speaker, success coach, and survivor-defendant expert consultant who has delivered keynotes, participated in panels, and facilitated training at major organizations, colleges and universities. She has also been*

profiled on CNN, MSNBC, and ABC, FOX, and NBC affiliates, The New York Times and Rolling Stone. Marissa holds a Bachelor's in Information Technology and Master's in Business Administration degrees. She is a domestic violence survivor and her case remains one of the most-referenced examples of injustice and source of insight, on domestic violence and criminalization of survivors. She is writing her first book.



## Miyhosi Benton, New York

Miyhosi Benton is Senior Associate at the Women & Justice Project (WJP), where she works to advance the leadership and build the power of currently and formerly incarcerated women. Miyhosi spearheads WJP's public engagement work and lead partnership work with women
